## **GENERAL POLICIES**

- All BBQ/grilling charcoal MUST be disposed of in designated coal pits. <u>DO NOT</u> place coals or ash into dumpsters, leach/septic mounds outside cabins, or in dunes. BBQs/grills are NOT permitted on the beach. Cabin BBQ grills MUST be kept at your unit.
- Firearms, archery bows, throwing knives/hatchets, air rifles/pistols, and any other illegal or dangerous weapons are <u>STRICTLY PROHIBITED</u>.
- **<u>NO</u>** cell phone use while driving. Speed limit 10 mph when passing pedestrians.
- **NO** swimming after dark. Lifeguards on duty daily.
- Nature trail, pavilions, picnic areas, and playground are closed after dark.
- **<u>NO</u>** landing and/or launching privately-owned motorized watercraft.
- NO glass containers and/or alcohol consumption on beach or nature trails.
- **<u>NO</u>** open fires, fireworks, portable fire pits, or metal detectors.
- NO drones or personal aircraft.

- Group gatherings **over 20 people <u>REQUIRE</u>** a facility rental.
- **NO** smoking/vaping in rental units. Smoking in designated areas only (50 ft away from any building.)
- **NO** digging, except at the beach shoreline, without review by Bellows Environmental Program.
- **<u>NO</u>** feeding or hunting feral animals.
- Authorized fishing areas are limited to the jetty (*adjacent to Waimanalo Stream*), between cabins 449B and 455B, and from cabin 455A up to the Distinguished Visitor fence. **The Distinguished Visitor area beyond the fence is OFF LIMITS.** *Occupants of beachside cabins between 315B to 449B are permitted to fish outside their cabins, provided they are on the rental agreement.* **All other areas, including the beach, are prohibited.**
- Recycle and use trash receptacles. Bellows AFS encourages all guests to recycle cans and bottles. Recycle bins are located around Bldg. 220 and throughout the property. <u>Dispose of coals in marked dispensers **ONLY**.

|          | I am the authorized DoD cardholder/sponsor. I understand that I am responsible for my conduct and the conduct of my dependents and sponsored guests. As the authorized cardholder/sponsor, I must be on site from <u>AT ALL TIMES</u> to account for each guest. I agree to the terms below.                                      |
|          | Due to fire code restrictions, NO SPECIAL FUNCTION AGREEMENTS will be processed for camper cabins/family campsites.   |
|          | I understand each authorized DoD ID cardholder is authorized to sponsor a maximum of 10 guests.   |
|          | My reservation allows a maximum of 2 tents and a maximum of 10 occupants per site at any given time.  |
| INITIALS | SPONSORING GUESTS Read and initial next to each item.   |
|          | Bellows AFS is a military installation; federal rules and regulations apply. All guests are responsible to abide by Bellows AFS policies. For details, I may refer to guest books, bulletin boards, or the website. I may also contact the FRONT DESK or SECURITY FORCES for questions or concerns.                               |
|          | All non-DoD ID cardholders must be sponsored onto the installation by an authorized cardholder. |          | Guests without an approved government-issued credential or state driver's license compliant with the <b>Real ID Act of 2005</b> are <b>REQUIRED</b> to provide a second form of identification prior to being granted installation access.  |
|          | ALL guests are subject to criminal background checks prior to accessing the installation. Guests with unfavorable information WILL BE DENIED access to the installation, regardless of sponsorship by authorized DoD ID cardholders.  |
|          | All non-DoD affiliated guests under the age of 16 <b>MUST</b> have a school ID or photo ID on their person at all times. All non-DoD affiliated guests age 16 and over <b>MUST</b> have a valid government/state ID on their person at all times.   |
|          | Foreign National guests will <b>NOT BE ALLOWED</b> base entry unless/until they have been properly vetted through SECURITY FORCES. Requests are accepted <b>ONLY</b> within a <b>three (3) month to thirty (30) day window</b> .  |
|          | All vehicles entering Bellows AFS must be ready to present the following items to the Sentry. All vehicles are subject to search.         • Current driver's license       • Current vehicle registration       • Rental Agreement (if applicable)         • Current proof of insurance       • Current vehicle safety inspection |

| INITIALS   | <b>Check-in</b> is <b>3 pm</b> , and <b>check-out</b> is <b>10 am</b> . Approval for late check-out is required. Due to high occupancy, late check-outs are usually not granted.   |  |
|  | If granted, a late check-out is to an Approval of face check-out is required. Due to high occupancy, face check-out safe usually not granted.<br>If granted, a late check-out fee of \$10 per 30 minutes may be incurred. An extra day will be charged if check-out occurs after 12 pm. 24-hour notice is required for refund consideration for early departures.  |  |
|  | I will adhere to <b>parking policies</b> . Up to 2 parking permits are issued per unit. Additional vehicles <b>MUST park in the authorized Overflow Parking</b> .<br>Permits are for my assigned unit only. |  | I will report any problems/issues with the rental unit to TURTLE COVE within the first 30 minutes of check-in. Refunds may NOT be authorized for unreported issues beyond the 30-minute period. For after-hours check-in, I will report to the FRONT DESK to update my credit card/other information and report any problems/issues with the rental site to TURTLE COVE by 10:30 am the following day.   |  |
|  | Refunds will <b>NOT</b> be granted due to weather, beach closure, power outages, insects, or other acts of nature (including loss or damage to personal property). Claims for damage/loss of personal property may be filed at any military Legal Assistance office.   |  |
|  | Dogs are permitted on the installation from sunrise to sunset in outdoor spaces unless staying in designated dog-friendly lodging<br>and <u>HAVE A SIGNED GUEST PET POLICY AGREEMENT</u> . Dogs are NOT PERMITTED in any building or under any covered structure, including condos,<br>pavilions, outdoor deck, Turtle Cove, and AAFES. Service Animals are allowed overnight with lawful inquiry. <i>NOTE:</i> Per the ADA, therapy/comfort<br>animals are NOT CONSIDERED "service animals". |  | Feeding or hunting of feral animals is prohibited and grounds for eviction without refund.   |  |
|  | Linen/bedding is <b>NOT</b> provided for this unit. I understand I am responsible for providing <b>my own</b> linen/bedding.   |  |
|  | No electrical power is provided at the camper cabins or family campsites. Generators, electrical extension cords, and party bouncers are <b>PROHIBITED</b> .   |  |
|  | Digging and/or leveling of the campgrounds is <b>PROHIBITED</b> .  |  |
|  | Cooking units <b>MUST</b> be located at least 6 feet from any structure, tent, or combustible material, and at least 3 feet off the ground. Smoking, candles, propane lanterns, cooking equipment, or any flammable device are <b>NOT</b> allowed inside the camper cabins or on camper cabin front porch.   |  |
|  | Outdoor cooking units <b>MUST</b> be located at least 6 feet from any structure, tent, or combustible material, and at least 3 feet off the ground. Open,<br>unattended fires and portable fire pits are <b>PROHIBITED</b> . Grills are for outdoor cooking only. I will <b>NOT</b> use grills to burn firewood. I will <b>NOT</b> place an<br>outdoor cooking unit on the picnic tables. I understand that BBQs/grills are <b>NOT</b> permitted on the beach. Coals <b>MUST</b> be cooled and disposed of in coal<br>dispensers only. I will <b>NOT</b> dispose of coals on the ground or in any trash receptacle, including dumpsters.   |  |
|  | I will be considerate of neighboring campers and cabin guests. I understand that excessive noise, profanity, or disturbance are grounds for immediate eviction. <b>Quiet Hours are enforced</b> Monday – Thursday from 10 pm – 8 am; Friday – Sunday and holidays from midnight – 8 am.  |  |
|  | Trash bags are <b>NOT</b> provided. I <b>MUST</b> provide my own trash bags for my space and place all trash in the <b>dumpsters</b> prior to check-out.   |  |
|  | A minimum fee of \$25 will be incurred if I fail to meet the acceptable standard of cleaning prior to check-out. I WILL dispose of all trash, including cigarette butts, in trash receptacles and place recyclable items in marked recycling bins nearest to my site. I WILL ensure the outdoor cooking grill and Camper Cabin/Campsite are clean, Camper Cabin/Campsite packet and Camper Cabin key are returned. I understand I must provide my own trash bags for. I WILL NOT use the trash receptacles along the walking path (parallel to Tinker Rd) for large-volume disposal. I understand that a \$25 fee will be incurred for each missing or broken weighted bucket in the Camper Cabin area.  |  |
