

1. INTRODUCTION TO BELLOWS MARKETPLACE PURPOSE

Bellow Air Force Stations is dedicated and committed to work with, contribute, volunteer, and support the local communities. We are striving to help local businesses grow in a friendly and safe environment, promote locally-made products, provide education, and connect with the community.

2. POLICIES: RULES AND REGULATIONS

- a. <u>Applications:</u> May be found on line at www.bellowsafs.com/marketplace. All applications must be submitted prior to the requesting date. Payments of cash or charge only. Payments may be done in-person daily from 8 am to 6 pm at Turtle Cove Bldg. 220 or via phone at 808-259-4135.
- b. **<u>Cancellations</u>**: Refunds or date changes will not be issued.
- c. <u>Bad Weather:</u> Rain or shine unless deemed unsafe/hazardous per Bellows AFS. Refunds will be issued if canceled by Bellows AFS.
- d. No Shows: Refunds or date changes will not be issued.
- e. <u>Documentation</u>: Special Event Food Establishment Permit and Food Handlers must be on site at all times. Vendor will be subject to inspections.

3. BOOTH MANAGEMENT

- a. <u>Dimensions</u>: Each site will be no more than two (2) 10x10 tents. Each vendor is required to bring their own equipment, tables, shade tents. Shade tents must be secured. An additional 10x10 may be used for cooking.
- b. Vehicles: Parking will be designated by Bellows AFS.
- c. **Booth Assignments:** Designated sites will be provided. Sites will be issued based on first come, first served basis on the day of the event.
- d. Fees and Payments: Payments must be made in order to reserve a space.
- e. <u>Pets:</u> Vendors are not allowed to bring their pets. Only service animals are permitted.
- f. First Aid: Vendors must provide their own first aid kits.
- g. Locally Grown Produce Only: No produce or plants grown out of state shall be allowed for sale.
- h. Alcoholic Beverages and Smoking: No alcoholic beverages or smoking permitted.
- i. <u>Signage:</u> Vendor must have signage identifying their business. Prices for all products must be displayed and legible for customers.
- j. <u>Trash:</u> Vendors are responsible to maintain and clean their area and surroundings. Vendors are responsible for disposing their own trash, to include but not limited to coals and oil.
- k. **Taxes:** All vendors must comply with all Hawaii State, County, and Federal tax laws. Any tax violations may lead to termination of future participation.
- I. Hours of Operation: 9 am 5 pm; daily.

5. CRAFT AND MERCHANDISE REQUIREMENTS

All merchandise must be locally produced; verbiage/logos in good taste - no profanity.

6. CULTURAL AND EDUCATIONAL REQUIREMENTS

No soliciting, collection of donations, or selling of goods. Booth to be used for cultural and educational experience only.

Refunds must be requested no later than 24 hours prior to the event date.

LOCATION

Located at the intersection of Kalaniana'ole Highway and Tinker Road. No electricity, restrooms, or water available on the site. Vendor must supply their own trash bags and remove them when leaving. Set up begins at 8 am; area must be cleared out by 6 pm. Do not block the Bellows entry sign from view of the main road.
